

## **R-SEENET™** End User License Agreement

NOTICE TO USER: THIS IS A CONTRACT. READ THE TERMS AND CONDITIONS OF THIS END-USER LICENSE AGREEMENT ("EULA") CAREFULLY BEFORE COMPLETING THE INSTALLATION PROCESS. BY CLICKING THE APPLICABLE BUTTON TO COMPLETE THE INSTALLATION PROCESS, YOU ARE ACCEPTING AND AGREEING TO BE BOUND BY THE TERMS OF THIS EULA. THIS EULA IS A LEGAL AGREEMENT BETWEEN YOU (EITHER AN INDIVIDUAL OR AN ENTITY) AND ADVANTECH, CO., LTD., A TAIWAN, R.O.C., CORPORATION ("ADVANTECH"). IF YOU ARE NOT WILLING TO BE BOUND BY THE TERMS OF THIS EULA, CLICK THE APPROPRIATE BUTTON TO CANCEL THE INSTALLATION PROCESS, DO NOT INSTALL OR USE THE SOFTWARE, AND RETURN THE SOFTWARE WITHIN THIRTY (30) DAYS OF RECEIPT (INCLUDING ALL ACCOMPANYING WRITTEN MATERIALS, ALONG WITH THEIR CONTAINERS) TO ADVANTECH AT THE ADDRESS LISTED BELOW FOR A REFUND.

- 1. GRANT OF LICENSE. Subject to the terms and conditions of this EULA and in consideration of your payment to ADVANTECH of the full amount of the license fee, ADVANTECH grants you a limited, non-exclusive, non-transferable, non-assignable right to use the computer software product of ADVANTECH and its licensors which you are currently installing (the "SOFTWARE"). No source code or other human readable form of the SOFTWARE is provided to you under this EULA. All rights not expressly granted to you in this EULA are reserved to ADVANTECH. For each Software license key that you purchase from ADVANTECH, you may: (i) use the Software on any single Computer, unless the Documentation clearly indicates otherwise; and (ii) copy the Software for back-up and archival purposes, provided any copy must contain all of the original Software's proprietary notices and a notice that it will not be used for transfer, distribution or sale.
- 2. RESTRICTIONS; INSTALLATION. Notwithstanding any provisions in this EULA to the contrary, you may not: (i) decompile, disassemble or reverse engineer the SOFTWARE except to the extent such foregoing restriction is expressly prohibited by applicable law; and (ii) directly or indirectly, export, re-export, or ship the SOFTWARE in violation of United States laws and regulations (or the laws and regulations of the applicable jurisdiction in which you use the SOFTWARE). You shall be solely responsible for installation and use of the SOFTWARE.
- 3. PAYMENTS. In consideration of the license and rights in the SOFTWARE granted hereunder, you agree to pay to ADVANTECH the non-contingent, non-refundable (except as noted in the Notice to User provision above) license fee specified in the applicable purchase order or invoice pursuant to which you licensed the SOFTWARE. All license fees are exclusive of taxes and you agree to bear and be responsible for the payment of all such taxes (except for taxes based upon ADVANTECH's income) including, but not limited to, all sales, use, rental receipt, personal property, import, and value-added or other taxes which may be levied or assessed in connection with this EULA.

- 4. COPYRIGHT AND OTHER RIGHTS. The SOFTWARE is owned by ADVANTECH and/or its suppliers and is protected by copyright laws and international treaty provisions. The SOFTWARE is licensed not sold to you. Further, the SOFTWARE contains trade secrets and other confidential and proprietary information of ADVANTECH and/or its suppliers.
- 5. LIMITED WARRANTY. ADVANTECH warrants, for your benefit alone, that for a period of thirty (30) days from the date the SOFTWARE is shipped to you (a) the SOFTWARE will perform substantially in accordance with the accompanying written materials, and (b) the medium on which the SOFTWARE is recorded will be free from defects in materials and workmanship under normal use and service. Any replacement SOFTWARE will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Some states/jurisdictions do not allow limitations on duration of an implied warranty, so the above limitation may not apply to you. You must obtain a Return Material Authorization number from ADVANTECH before returning the SOFTWARE under warranty to ADVANTECH and you agree to pay expenses for shipment to and from ADVANTECH. When returning the SOFTWARE you must provide written notice specifying in detail how the SOFTWARE allegedly fails to perform in accordance with the above Limited Warranty. The Limited Warranty is void if failure of the SOFTWARE has resulted from accident, abuse, misapplication, third party products (i.e., hardware or software) used by you which are not intended by ADVANTECH for use with the SOFTWARE, or unauthorized maintenance of the SOFTWARE.
- 6. CUSTOMER REMEDIES. ADVANTECH's sole obligation (and your sole and exclusive remedy) with respect to the foregoing Limited Warranty shall be to, at ADVANTECH's option, return the fees paid or repair/replace the SOFTWARE, provided that ADVANTECH receives written notice of applicable defects during the warranty period. You may not bring an action to enforce your remedies under the foregoing Limited Warranty more than one (1) year after the accrual of such cause of action.
- 7. LIMITATION OF LIABILITY. The entire liability of ADVANTECH and its licensors, distributors, and suppliers (including its and their directors, officers, employees, and agents) is set forth above. To the maximum extent permitted by applicable law, in no event shall ADVANTECH and its licensors, distributors, and suppliers (including its and their directors, officers, employees, and agents) be liable for any damages, including, but not limited to, any special, direct, indirect, incidental, exemplary, or consequential damages, expenses, lost profits, lost savings, business interruption, lost business information, or any other damages arising out of the use or inability to use the SOFTWARE, even if ADVANTECH or its licensors, distributors, and suppliers has been advised of the possibility of such damages. You acknowledge that the license fee for the SOFTWARE reflects this allocation of risk and that ADVANTECH would not otherwise license the SOFTWARE to you. If the foregoing limitation of liability is not enforceable because the SOFTWARE is determined by a court of competent jurisdiction in a final, non-appealable judgment to be defective and to have directly caused bodily injury, death, or property damage, in no event shall ADVANTECH's liability for property damage exceed the amount of license fees you have paid for the SOFTWARE to ADVANTECH in the preceding (12) twelve months.

- 8. U.S. GOVERNMENT RESTRICTED RIGHTS. If you are an agency, department, or other entity of the United States Government, the use, duplication, reproduction, release, modification, disclosure or transfer of the SOFTWARE, or any related documentation of any kind, including technical data or manuals, is restricted in accordance with Federal Acquisition Regulation 12.212 (as amended or supplanted) for civilian agencies and Defense Federal Acquisition Regulation Supplement 227.7202 (as amended or supplanted) for military agencies. The SOFTWARE is commercial computer software and the related documentation is commercial computer software documentation. The use of the SOFTWARE and related documentation is further restricted in accordance with the terms of this Agreement, or any modification hereto.
- 9. GENERAL. THIS EULA IS GOVERNED BY THE LAWS OF THE R.O.C. AND CONSTITUTES THE COMPLETE AGREEMENT BETWEEN YOU AND ADVANTECH. IT SUPERSEDES ANY ORAL OR WRITTEN PROPOSALS, PRIOR AGREEMENTS, PURCHASE ORDERS OR ANY OTHER COMMUNICATION BETWEEN YOU AND ADVANTECH RELATING TO THE SUBJECT MATTER OF THIS EULA. Notwithstanding the foregoing, the parties agree that ADVANTECH shall (in its sole discretion) have the right to take action in the courts of the jurisdiction where you use the SOFTWARE, under the laws that normally apply in such jurisdiction, to enforce the proprietary rights referenced of ADVANTECH in the SOFTWARE and/or to collect any overdue amounts from you. This EULA shall automatically terminate upon failure by you to comply with its terms, in which event you must immediately stop any further access to or use of the SOFTWARE and destroy all copies of the SOFTWARE. If any action is brought by either party to this EULA against the other regarding the subject matter hereof, the prevailing party shall be entitled to recover, in addition to any relief granted, reasonable attorney fees and court costs. If any provision of this EULA is held invalid, the offending clause will be modified so as to be enforceable and, as modified, shall be fully enforced, and the remainder of this EULA will continue in full force and effect.
